The GLAStar Awards

Since 1995 the Great Lakes Area Star (GLAStar) Awards have honored excellence in the Michigan apartment industry. The 2012 winners will receive recognition and a prestigious award at the Gala Awards dinner on November 16, 2012.

All members of PMAM are eligible to enter. You may enter as many categories as you like, each entry must have a separate entry board and supporting materials. All categories are for both conventional and affordable housing.

The vendors have their own categories. Good luck!

This year you will receive one brochure with information on both the Awards and Education for the GLAStar Conference!

HOW TO PREPARE A GLASTAR BOARD

- The entry is to be prepared on a board made of foam or cardboard. It cannot be larger than 36"H X 48"W. Correct size will receive 10 points.
- All materials must fit on the entry board. Please carefully secure all items as the board will be moved for judging, storage and display.
- Gather documents, photos, articles, brochures or other materials for your entry board. Eligible entry activity must have occurred between <u>September 1, 2011 and</u> <u>September 1, 2012.</u>
- Create or secure one letter of nomination. <u>The nomination letter will receive 0-10 points.</u>
- Solicit letters of reference. The reference letters will receive 0-10 points.
- Use the gathered material together with a theme or design that will help to demonstrate why your entry should win this award. Place the material on the entry board.
 Design of the board will receive 0-5 points.
- Complete the entry form and attach form to back of entry board.
- Also attach to the back of the entry board an envelope that includes a copy of the entry form, \$40 check payable to PMAM, and a 4" x 6" glossy photograph with typed label including: This picture is for the slide show!
 Category name, community name, vendor name, and/or individual name, unit count or age, city and apartment association chapter. This picture is for the slide show! Do not take a picture of your board! (You may use one check to pay for multiple boards, call us first!)
- Include information on each of the scoring criteria listed under the award category
 you are entering. Each criteria listed will receive 0-10 points.
- Double check to ensure all these criteria are included on your entry.
- Entries are due no later than September 28th, 2012 by 5pm. You may turn them in early too!
- Deliver your entry board to your local chapter of PMAM. Call 616-531-5243
